ORDER

Gene W. Doeling, trustee in this matter, filed a Notice of Sale, Abandonment, Lease or Settlement on November 2, 2012. No objection was filed as to the proposed settlement of the remaining claims in Adv. No. 12-6024. The debtors shall pay to the estate the sum of \$3,500, payable over three months beginning October 1, 2012 for the nonexempt receivables of \$1,460, the undisclosed camper that had a value of \$750, and the nonexempt equity of \$1,624.70 in the 2005 GMC Yukon. The debtor shall also assign and transfer ownership of the domain names of "mckmama.com" and "mycharmingkids.net" to the bankruptcy estate, and will assist the bankruptcy estate in obtaining title and ownership of these domain names so they can be liquidated by the bankruptcy estate. The Court does, based upon all records herein, order that the trustee's notice is hereby granted.


